Guide Services Agreement

1. This Guiding Agreement Between:

Maine, hereinafter referred to as "Guide" was entered into on this ____ day

2. The hunter agrees to pay to Guide the following fee:

Hunter shall pay the fee as follows: Hunter shall make a **deposit (recommend 50% down unless other arrangements are made)** due at the time of this agreement to reserve his/her hunting dates and location. Half of the remaining balance on the hunt shall be paid 30 days prior to start of the hunt and the final payment for the hunt is due in full on the first day of the hunt.

ALL deposits are non-refundable and will be transferred to the next years hunt only. All cancellations are to be made 60 days prior to your scheduled hunt wherefore the hunter may transfer his/her hunt deposit and fee's to another hunter (not already booked with the Guide) or may roll all deposits and fee's paid to the next year hunt. Hunter understands that any cancellations made after the 60 day window will result in a forfeiture of any and all deposits and fee's paid to Guide, unless prior arrangements are made.

3. Hunters represents and warrants that he/she is, and will at the time of the hunt be, licensed and permitted to engage in bow and arrow and/or firearm hunting by the State of Maine. Maine hunting Licenses can be purchased on-line at <http://www.state.me.us/ifw/>
4. Hunter agrees to and shall comply with all applicable state laws, federal laws and OAC Guide Service rules and regulations pertaining to the hunting and harvesting of any game and agrees that he/she will not engage in any unlawful activity while he/she is engaged in hunting activity pursuant to this Agreement.
5. Guided Hunter will be granted a specific and exclusive location/locations (bear & deer) in which to hunt pursuant to this Agreement, and Hunter agrees to conduct all of his/her activity strictly within the bounds of the area assigned to the Hunter by the Guide.

6. Hunter agrees not to bring any third persons to the premises used for hunting and understands that any such persons will be treated by Guide, landowner and their agents as trespassers.
7. Hunter agrees not to bring firearms onto any of the premises used for hunting at anytime unless otherwise used for scheduled hunting reasons.
8. Guide represents that he/she has authority to enter into this Agreement and grant Hunter access to specific premises used for guided hunts *(areas used during semi and unguided hunts may not need or have leased access requirements. Access to these areas will be the sole responsibility of the Hunter)*.
9. Hunter agrees not to solicit nor accept any type of solicitation from any of the Guides, Employees, landowners, neighboring landowner and their agents for the purpose of any type of hunting.
10. Hunter agrees not solicit nor accept any type of solicitation from any Maine landowners and their agents for the purpose of any type of hunting within a 10 mile radius from ANY of OAC Guides properties.
11. Hunter agrees that he/she is alone responsible for the safety of himself/herself and others and understands that it is his/her responsibility to insure his/her own safety while on the premises and shall inspect and secure all tree stands (if appropriate) adequately, and at ALL TIMES wear a safety belt or harness while positioned on any stand of any type.
12. Hunter acknowledges that participating in hunting is a dangerous activity to himself/herself and others and for himself, and personal representatives, heirs, and next of kin, hereby releases, waives, discharges and covenants not to sue the OAC Guide, Guides proprietor or any employees, members, shareholders, partners or other owners of OAC Guide Service, Elm Mountain Group, LLC, SEVENTHRIDGE and The Allain Group, LLC; landowners, or lessees; or their agents, insurers, personal representatives, employees, guides, assigns, heirs, and next of kin (hereinafter "Releasees"); for any and all loss of damage, or any claim of damage, or any claim of damage therefore, on account of injury to person or property or resulting in the death of hunter, whether caused by negligence of Releasees or otherwise while hunter is on premises used for the hunt or in any manner conducting activity pursuant to this Agreement.

Furthermore, hunter agrees to indemnify the Releasees and each of them from any loss, liability, damage or costs and attorney's fees which Releasees may incur due to the presence of hunter in or on aforesaid premises whether caused by the negligence of Releasees, Hunter or otherwise.
